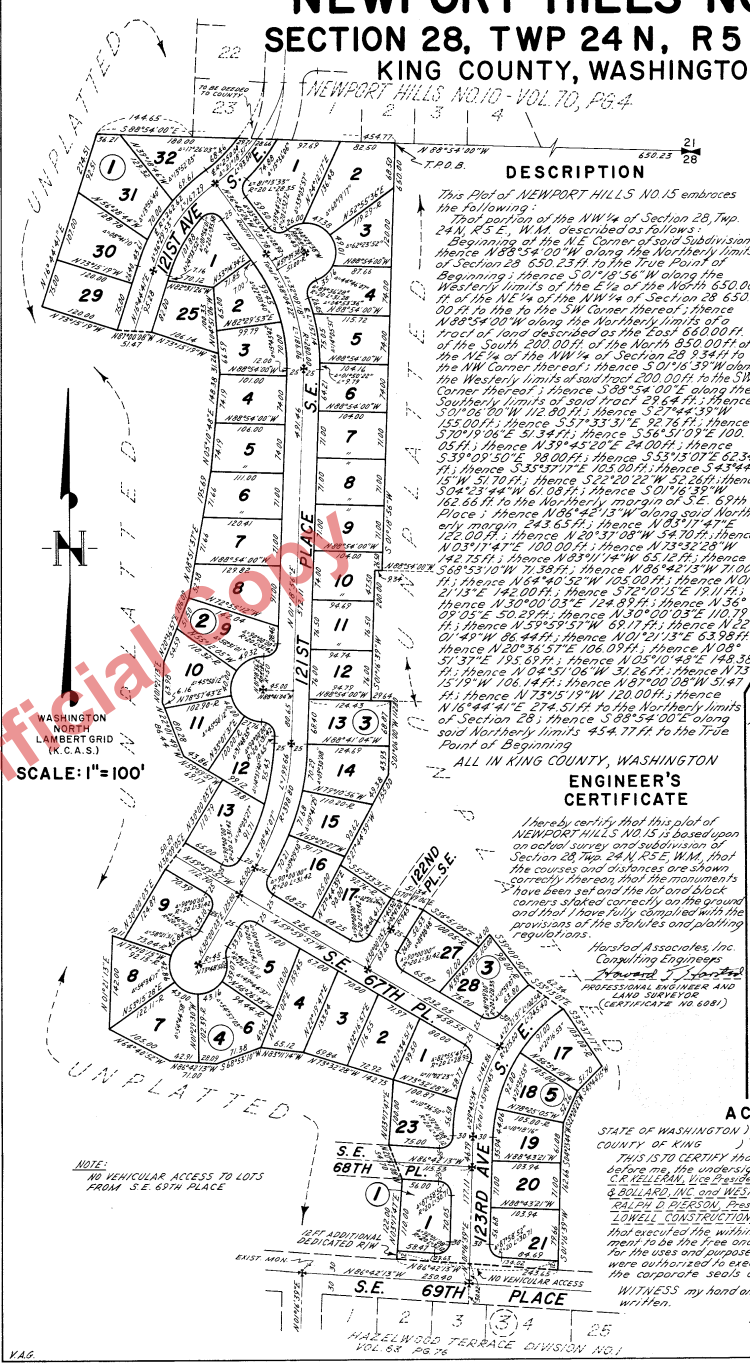


NEWPORT HILLS NO. 15 SECTION 28, TWP 24 N, R 5 E, W.M. KING COUNTY, WASHINGTON
